Dear friends,

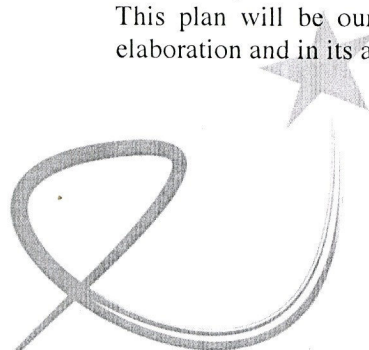
